During the 14 months that the district's application has been in review, there have been two changes.

First, the part number for the Chromebooks has changed. This amendment reflects that updated part number.

Second, the district purchased a number of desk tops out of local budget funds as the delay was too long. As a result, the district is redirecting the funds to purchasing additional chromebooks to increase the availability to students. The net result is a decrease of \$280.00.
